### RC39 Officers attend the NYSUT Retiree Contiguous ED51-53 (At-Large) Meeting on Oct 6-7, 2014

Peter Herron, Joan Prymas, George Wybenga, Judith Holmes, and I attended the NYSUT Retiree Contiguous ED51-53 (At-Large) Meeting on Oct 6-7, 2014, in Albany. All the central officers of NYSUT: Karen Magee, President; Andrew Pallotta, Executive VP; Catalina Fortino, VP, Paul Pecorale, VP; and Martin Messner, Secretary-Treasurer, dropped in at various times to introduce themselves to us and to offer support. Paul Pecorale, in charge of Retiree Affairs.

There were 2 plenary sessions and more than 10 various group meetings to discuss issues such as Social Security and Medicare, NYSUT's services and benefits for members, a proposed change of retiree delegates to NYSUT and AFT Conventions, a consideration of assessing membership dues from retirees, effectiveness of Retiree Councils' communication with members, and retiree participation in and support for their councils, etc. Four resolutions were adopted for NYSUT to enact and they will be published in NYSUT journals for your perusal.

Among the invited guests to the meeting were Thomas DiNapoli, NYS Comptroller and Andrea Stewart-Cousins, NYS Senator and Senate Minority Leader. As always, Comptroller DiNapoli assured us of the soundness of the NY Pension Fund, the third largest in the nation and that he would never allow NY to have anything other than a defined pension plan. Senator Stewart-Cousins stated that as a strong advocate of public education she will always push hard for its proper funding. All the speakers at the meeting urged us to be active in the coming November elections.

The five of us from RC 39 also met to discuss our council's specific concerns and decided on the following:

- 1. Submitting our newsletter to compete for the NYSUT Communications Awards.
- 2. Contributing \$200 to Long Island Cares.
- 3. Actively recruiting members to run as Board Members (elections are this coming year).
- 4. Encouraging members to establish local chapters and to attend regional meetings.
- 5. Urging members to share their activities and ideas in our newsletter.

#### 2014 NYSUT RETIREE CONTIGUOUS E.D. MEETING FINAL REPORT ON RESOLUTIONS, October 6-7, 2014,

#### **Resolution 1**

Support constitutional amendment to overturn Citizens United Decision by U.S. Supreme Court

Whereas, the United States Supreme Court declared in Citi- STATEMENT OF FINANCIAL POSITION zens United that corporations are persons and that corporations cannot be limited in political giving, by a 5-4 vote; and Whereas, the minority members of the Supreme Court strongly objected; and

Whereas, Supreme Court Justice Stevens, in January 2010, STATEMENT OF REVENUE AND EXPENSES wrote:

"Corporations have no consciences, no beliefs, no feelings, no thoughts, no desires. Corporations help structure and facilitate the activities of human beings, to be sure, and their 'personhood' often serves as a useful legal fiction. But they are not themselves members of "We the People" by whom and for whom our Constitution was established;" therefore

RESOLVED, that NYSUT and its state and national affiliates support a constitutional amendment to clarify that "free speech" as envisioned by the framers of the U.S. Constitution, was limited to individuals and groups of individuals, not incorporated entities.

#### **Resolution 2**

Support Constitutional Amendment to overturn Hobby Lobby Decision by U.S. Supreme Court

Whereas, the United States Supreme Court, by a 5-4 decision, upheld Hobby Lobby's First Amendment religious liberty position; and

Whereas, this decision denies to many employees, especially women, the right to make the fundamental decisions on health and reproductive health matters; and

Whereas, the court affirmed the employer's right to make decisions on health and reproductive health matters under the religious liberty clause of the First Amendment protecting the employer's right; and

Whereas, the decision additionally narrows the decision made by both houses of Congress on the Affordable Health Care Act; therefore be it

RESOLVED, that NYSUT and its state and national affiliates support a constitutional amendment to overturn the Hobby Lobby decision by the U.S. Supreme Court.

#### **Resolution 3**

Support and Defend Defined Benefit Pensions at both State and Federal levels for all Public Employees

Whereas, many employers in the private as well in the public sectors are moving to a defined contribution pension

Whereas, defined contribution plans could subject workers to the unpredictability of the stock markets; therefore be it

**RESOLVED**, that NYSUT and its state and national affiliates will continue to defend defined benefit pensions at both state and federal levels for all public employees as well as those in the private sector.

#### Resolution 4

**Earned Benefits** 

Whereas, earned benefits, namely Social Security and Medicare, are under attack by some political leaders, the media and others and maligned as "entitlements;" and

Whereas, some members of Congress support the unjust idea of a "chained" CPI which would, if implemented, reduce the Cost of Living Adjustment (COLA); and

Whereas, neither Social Security nor Medicare add to the deficit; and

Whereas, that to use the word "entitlements" is to imply that Social Security and Medicare are gifts bestowed on seniors and other recipients, which they are not. They have been and continue to be earned benefits; and

Whereas, Social Security and Medicare have an enormous positive economic and social impact on beneficiaries as well

#### **MOVIES NOW AND THEN**

#### THE SECRET LIFE OF WALTER MITTY



James Thurber's original short story THE SECRET LIFE OF WALTER MITTY published in the New Yorker in 1939, created an iconic character, an average guy with an ordinary life and an extraordinary ache for some kind of greatness. Our sweetly sad journey with Walter takes us around town, as he drives with his nagging wife on errands, and delves into daydreams of magnificent imaginary accomplishments, great deeds that digress from the ordinariness around him. As a commander of a hydroplane, a great and admired surgeon, or an aggressive crime trial witness, Walter's dream roles are silly stereotypes, but so satisfying. They are classic idealizations in their day. The story was first made into a film in 1946, starring Danny Kaye. The bossy wife character was changed to a mother, and augmented by beautiful blonde Virginia Mayo, adding romantic possibilities. The daydreaming Walter, a magazine proofreader, with typical Danny Kaye antics, daydreams as a Mississippi gambler, gets involved with the high fashion world and an evil psychiatrist (Boris Karloff), and in a scheme to steal the Dutch Crown Jewels. Walter's real life gets an action plot, and the secret life dreams go wild. The song "Beautiful Dreamer" leaks onto the soundtrack. Danny Kaye fans could probably take it. Author James Thurber offered the film's producer Sam Goldwyn \$10,000 not to make it. No luck.

The latest version of THE SECRET LIFE OF WALTER MITTY, released in 2013, resonates with elemental similarities to earlier filmic work of its director and star, Ben Stiller, of ZOOLANDER and MEET THE FOCK-ERS fame. Walter, the main character, is his own avatar in a videogame-like series of fantasies. His heroics rage against no particular enemy, and his daydreams center on distraction from current specific troubles, with particularly current challenges: his situation with his mother (Shirley MacLaine) is trying, his unnoticed crush on a pretty girl at work (Kristen Wiig) is saddening, his coworkers at Life Magazine bully him, and the new managers rife with little black beards and gelled pompadours have threatened his job. Humor is not missing in some of the broad satirical characterizations.

Less achieving than a nerd, Walter is a dork. He is the "negative asset manager" and one important asset, which he is responsible for, a special negative, is strangely missing. This negative will produce the photograph selected by the great photographer Sean O'Connell (Sean Penn) to be on the cover of the last print version of Life Magazine, which was folding down into an on-line corner of the publication world. There is some irony in the notion that a negative, a product of the non-digital film-bound early camera, is an unknown entity to portions of the Stiller social media fan crowd. The final print edition of Life cannot be produced without this old pre-digital element.

Walter is unskilled in social media but great at skateboarding. His secret life moves into adventures where he seems to play in some kind of a computer war game – flying and falling and crashing and swimming, part Patton, part Spiderman. "Ground control to Major Tom…" sets a mood. Thurber's journey was just around his hometown, but this Walter, to reclaim his effectiveness in his job, searches the world for the adventurous photographer Sean, with forays into Greenland, finally finding him in Iceland, on a glacier. Sean's revelation about where he put the negative, and a stroke of luck, allow Walter, to find it. The cover can be printed!

And what will be on the final cover of Life? In Thurber's short story, in the final episode of his secret life, Walter seems to realize an ultimate truth about life. With Danny Kaye in the role, Walter gets the girl and winds up with a nice editorial job. In Stiller's film, Walter gets the girl, a readymade family, saves everybody's job and on the cover, well, --no spoilers, but oh, how far from Thurber. Clearly, the old classic has been adapted to convey today's popular values.
