NYSUT is putting First Book in the hands of students with the help of the non-profit organization First Book Inc., and the American Federation of Teachers, a NYSUT national affiliate. Books are made available at low to no cost to high-needs schools and nonprofit programs serving low-income families and kids in need. First Book Inc., obtains new, high-quality books donated from book publishers and through monetary donations from people and companies that support the program.

A major purpose of the NYSUT Retiree Contiguous E. D. 51-53 (at large) meeting is to give retiree councils an input to the policy decisions of the NYSUT. This is done by retiree councils submitting resolutions that will be sent to NYSUT for policy considerations. Four resolutions were submitted and forwarded to NYSUT. The first resolution involved having retirees better integrated into the decision process of NYSUT. The second resolution requests NY-SUT to work with legislators to provide relief to the cap on SALT deductions. The third resolution encourages NY-SUT to promote Unionism. The fourth resolution asked NYSUT to work with other state public employee unions to negotiate for a Medicare Part D reimbursement, a permanent reimbursement for Medicare Part B and the surcharge of Parts B and D.

YOUR HEALTH CONNECTION By Frances S. Hilliard, RN, MS Professor Emerita, Nassau Community College

When it comes to increasing your risk for skin cancer, exposure to both UVA and UVB rays are both dangerous. UVA rays do not cause sunburn, so people often think these rays are safer. However, the longer wave lengths of UVA allow these rays to penetrate deeper into the skin, possibly damaging cellular DNA and leading to skin cancer. UVA rays are <u>not</u> blocked by glass, so exposure can occur when traveling in a car. UVB rays are the ones that result in sunburn, which can cause lasting damage to skin cells.

Always protect yourself by using a sunscreen that offers protection from both types of rays. This is usually described as a "broad spectrum" sunscreen. Wear sunscreen whenever you are outdoors (summer or winter), and be sure to apply it sufficiently and evenly.
